#### **QUANTUM LEAP FARM**

Quantum Leap Farm serves children and adults experiencing mental, physical or behavioral disabilities including those resulting from accidents or wounds of war.

When Mark enlisted in the Army at eighteen years old, the Warrior Ethos was drilled into his

brain to always place the mission first, never accept defeat and never quit. After being injured and suffering from a severe head injury and broken bones, he developed PTSD and anxiety. His mission in the hospital became rehabilitation. After leaving the hospital, his mission was not as clear and he fell into a depression. That is where Quantum Leap came in. Mark said, "When I found Quantum Leap Farm at the peak of my depression, all of that changed. While riding my horse Sonic weekly, I was drawn to the mission of volunteering and found a love for that. It was the love of the tasks, the love of the clients, and the love of the family that Quantum had become which became my new mission." When his daughter suffered a stroke in utero and was born with disabilities. his mission changed again. Because of his struggles, he knew he could lead and offer the lessons he learned from Quantum Leap Farm. #### PROJECT ONE VET @ A TIME

Project OVAT is a charitable organization that focuses on the legal and medical support of veterans who are attempting to navigate the complicated Veterans Administration disability programs.

Amy joined the Coast Guard in 1988 and retired on 1 September 2017. She served 25 years at various duty stations across the United States. While in the military, Amy tore her right knee ACL resulting in numerous surgeries, arthritis, and a need for knee replacement in the future. She was also plagued with other ailments including her lower back, shoulder, and feet. She was originally awarded 90% support from the Veterans Administration but was notified that they had made an error and they changed her rating to 30%. Despite countless hours disputing their finding, she continuously ran into obstacles along the way. Project OVAT has stepped in to fight for Amy and will cover all legal expenses and paperwork required to file a claim on behalf of Amy. As a result, she will receive the back pay she deserves. #### **LEASHES OF VALOR**

Leashes of Valor works to provide every post 9/11 veteran with a highly-trained service dog to assist them in mitigating the symptoms of Post-Traumatic Stress Disorder (PTSD) or a Traumatic Brain Injury (TBI).

Perry is an Army veteran and a former flight medic who, after an 18-month deployment to Iraq, was diagnosed in 2008 with post-traumatic stress disorder. He is also a survivor of a subsequent traumatic brain injury that occurred during a 2010 deployment to Kosovo with the National Guard, worsening his PTSD. Perry was provided a Rottweiler named Atlas who is not just a house pet. Atlas is a trained service dog who can sense Perry's anxiety levels and "ground" him by sitting on his feet, as a weighted blanket can calm an autistic child. He can remind Perry to take his medicine, keep crowds away, block anyone approaching from behind, notify Perry when a migraine is coming, find the closest exit in a building, pick up and retrieve items, wake Perry from nightmares and even force him out of the house when he is being too reclusive. As opposed to simply writing a check, consider the following ...

#### ☐ GIFTING APPRECIATED STOCK

Many successful investors have appreciated stock in their portfolio with potentially meaningful appreciation. This appreciation becomes a (capital gain) taxable event when sold, but if directly gifted to a qualified 501(C)3 organization such as The Patriot Fund, this tax is avoided by both the donor and the beneficiary.

**Donor** – has the benefit of taking a tax deduction equivalent to the full market value of the stock gifted and the donor completely avoids the capital gain tax.

**Beneficiary** – receives the stock and sells it at full market value. A qualified 501(C)3 organization is exempt from capital gain taxation.

#### DONOR ADVISED FUND

Many successful and potentially philanthropic investors find an immediate need for a tax deduction to offset potential capital gains and income tax exposure. Contributing appreciated stock to a Donor Advised Fund allows donors to benefit by a current tax deduction while spreading the beneficiary gifts over time.

**Donor** – has the benefit of realizing a greater current income tax deduction while not committing the entire value immediately. Gifts can be "advised" to the custodian over time.

**Custodian** – there are many qualified donor-advised funds available at a number of Trust companies. The Trust company receives the

granted stock, sells it without capital gain tax exposure, and on the advice of the donor, will make the distribution to qualified charitable organizations.

**Beneficiary** – as with any gift, the beneficiary 501(C)3 organization is free from taxation and in this case, several beneficiaries may be funded over time.

#### ■ INDIVIDUAL RETIREMENT ACCOUNT DISTRIBUTIONS

Financially successful individuals may have a meaningful amount of capital accumulated in Individual Retirement Accounts (IRA's) which they feel is available for potential charitable giving.

For those over 59 ½ years of age, a withdrawal can be made payable to a qualified charity (Qualified Charitable Distribution – QCD), the amount of which is excluded from taxable income to the donor.

For those over 70 ½ years of age, Qualified Charitable Distributions up to \$100,000 can be counted toward satisfying your required minimum distribution (RMD).

#### □ FAMILY FOUNDATION

For some families of greater charitable desire, considering a Family Foundation may provide opportunities similar to the Donor Advised Fund but with greater flexibility, control and management. Such Foundations are used to not only fulfill family philanthropic planning desires but also to foster a legacy of such thought and strategy.
